AND WHEREAS it has become necessary to declare the objects and terms of the public charitable trust.


Now this deed of declaration of the public charitable trust witnesses as under.

4. President :

- 4.1 Sri Hari Om Pandey shall be designated as the life President, who shall be in charge of the day to day affairs of the Trust.
- 4.2 The President shall have power to administer the funds of the trust and any power exercisable by the Board of Trustees as may be delegated to the President.
- 4.3 The President shall hold office for life or until he resigns there from.


5. Trust Fund

- 5.1.1 The initial contribution of Rs. 11,000/- (Rs. Eleven Thousand only) made by the author of the trust shall hereby vest in the trustees and shall constitute the initial trust fund.
- 5.1.2 The trust fund may be augmented by the income from the initial fund and also by donations and other contributions from time to time.
- 5.1.3 That the Trust Fund can be applied for any charitable purpose other than those specified in Para 5 here in below.

6. Objects of the Trust :

The objects of the trust are as under :

- a) To open, found, establish, promote, set-up, run, maintain, assist, finance, support and/ or aid or help in the setting of and/ or maintaining and / or running hospitals, charitable dispensaries, child welfare centers, research centers, diagnostic centers, bank service centers, immunization centers, health centers and to apply or provide utility articles and services to patients, attendants and others and to provide medical relief and/ or aid to the suffering humanities.
- b) To establish, set-up, maintain finance support and/or help in the setting up and running schools and other educational institutions, orphanages, widow homes, lunatic asylums, or other establishments for relief and/ or help to the poor, old and/ or destitute.
- c) To give, provide and/or render food, medicine and other help and/or assistance in any shape or form to the poor deserving and needy persons.

- d) To give, provide and/or render monetary and/or other help and assistance for the relief of persons and animals affected by natural and other calamities such as flood, fire, famine, cyclone, earth-quake, storm, accident, drought, epidemic, to give donations, subscriptions or contributions to institutions, establishments doing relief work on such occasions.
- e) To promote, advance and encourage and/or aid in helping, promoting, advancing and encouraging primary, secondary including technical and medical education also physical training, training of handicrafts, fine art and other useful arts, crafts among the public including the establishment and maintenance of Kala Kendras and other welfare centers for them.
- f) To open, found, establish, promote, set-up, run, maintain, assist, finance, and/or help in the setting up and/or maintaining and/or running schools, colleges and other establishments or institutions for advancement of education and of knowledge in literature, teachers training humanities and all other useful subjects.
- g) To encourage education and training in handicrafts, fine arts among people in general and establish and found institutions imparting such education and to establish, maintain, support or help by monetary gifts or otherwise, centers and institutions for women and children and to provide social welfare works for women and children.
- h) To grant, pay or give scholarship, stipends, prizes, rewards, allowance and other financial assistance or help in cash or kind to students with a view to help them in prosecuting their studies in schools, colleges, educational institutions, technical institutions, art schools, institutions teaching commercial and other arts.
- i) To open, found, establish, promote, set-up, run, maintain, assist, finance, support and/or aid or help in the setting up and/or maintaining and/or running by monetary gifts or otherwise, centers, stadium, play grounds and parks for public use, sports and games and other social welfare works and/or activities.
- j) To open, found, establish, promote, set-up, run, maintain, assist, finance, support and/or aid or help in the setting up and/or maintaining and/or running institutions, centers, auditoriums and the like for the running of welfare and other services to the public and to provide meeting room for socially useful activities and functions.

- k) To open, found, establish, promote, set-up, run, maintain, assist, finance, support and/or aid or help in the setting up establishment, maintenance and/or running Dharamsalas.
- l) To promote, organize, administer, support, maintain, and/or grant aid to any person, institution, or society or organization what so ever having for its objects of charitable purposes and to incur expenditure in connection there with.
- m) To promote, assist and/or maintain all activities by what so ever carried on or wherever carried on in India in conformity with the objects of the Trust.
- n) To help in the preservation of useful animals.

7. **Enabling Powers.**

That for the furtherance of the objects of the trust, the trustees shall have the following powers :

- a) To accept any donation, contribution, grant or subscription in cash or in kind, from any person(s), body of persons or trust, Institutions, State or Central Government, Semi Government Departments, Local Authorities, etc. with or without conditions.
- b) To apply the whole or any part of the income of the trust, or the trust fund or accumulations thereto, to any one or more of the objects of the trust, as the trustees may, in their discretion, deem fit from time to time.
- c) To convert and deal with the trust property and/or any investments for the time being.
- d) To invest trust fund either in the purpose of mortgage of immovable property or in shares, stock or debentures or other securities and investments, or in deposits with or loans to any company, bank, firm or any other person and to alter, vary or transpose such investments, from time to time at the discretion of the Life Trustees.
- e) To borrow or raise or secure payments of moneys and also to lend money either with or without security.
- f) To sell, dispose of, alienate or otherwise deal with any property comprising the Trust Fund.
- g) To let out, demise any immovable property comprised in the Trust Fund for such period and at such rent on such terms and conditions as the life trustees in their discretion any think fit.

- h) To open account in the name of the trust, and institutions run/conducted by the Trust with a Bank or Banks, to operate such account and to give instructions to the Bank and to provide for opening and operation of such account by any one out of President, Secretary and Treasurer and the President can authorize any officer/ employee of the Trust to operate the account.
- i) To adjust, settle, compromise, compound, refer to arbitration, all actions, suits, claims, demands and proceedings regarding the Trust Fund.
- j) To make, very, alter or modify schemes, rules and regulations for carrying out the objects of the Trust and for the management of the affairs there of and/or running any institution in furtherance of the objects of the Trust and otherwise for giving effect of the objects of the Trust.
- k) To appoint or make provisions for the appointment of any person (including all or any of the Life Trustees and committees or administrator or Managing Trustees or any of the Life trustees and committees or administrator or Managing Trustees or otherwise) for the purpose of the administration of the Trust in such in such manner and subject to such rules and regulation as the Managing Committee may prescribe and also to appoint or provide for the appointment of separate Trustees to hold any fund or investment subject to the provisions of this deed in such manner and subject to such rules and regulations as the Managing Committee may from time to time think fit.
- l) To start, abolish discontinue and restart and charity or charitable institutions for the benefit of general public and to impose and conditions to any sub scription or donation made by them.
- m) To set apart and/or allocate the whole or a part of the income of the corpus of the Trust Fund of part there of for any of the objects of the Trust.



- n) To give aid by way of donations out of the income or the corpus of the Trust fund or otherwise to different charitable institutions, societies, organizations or Trusts in India which may have been established or which may here after be established for the like charitable purpose mentioned in these presents or any of them to enable such institution, societies, organization or Trustees to start maintain or carry out such charitable objects.
- o) To apply to the Government, public bodies, urban, local, municipal, district and other bodies, corporation, companies or persons for and to accept grant of money and of aid, donations, gifts, subscriptions and other assistance with the Government Departments, public and other bodies corporations, companies or persons, scheme and other work and matters within the objects of the Trust and to conform to any proper condition upon which such grants and other payments may be made.
- p) To take over or amalgamate with any other charitable trust, society, association or institution with similar objects.
