- To convert and deal with the trust property and/or any investments for the time being.
- d) To invest trust fund either in the purpose of mortgage of immovable property or in shares, stock or debentures or other securities and investments, or in deposits with or loans to any company, bank, firm or any other person and to alter, very or transpose such investments, form time to time at the discretion ofr the Life Trustees.
- To borrow or raise or secure payments of moneys and also to lend money either with or without security.
